




Case Transfer Staffing Data

FY 2024-2025 Exiting Out-of-Home Care Initiative





Percent of Adoptions Finalized with 24 Months of Removal & Percent of Adoption Goal Met









Placement Moves, Children in Out-of-Home Care (OHC)






➤ Number and Percent of Children Serviced in Residential Care














Trends for Foster Parent Recruitment

Percent of Foster Home Utilization and Teen Placement in a Foster Home



Last 15 Months through May 2025






